TERMS AND CONDITIONS FOR SI PREMIER LEAGUE (PL) 1 _

- This scheme is Valid on Purchases made from 25th June'25 30th Sept'25, from Digisol Premium Partner (National Distributor or respective Regional Authorised T1/Distributor). Similar Premier Leagues will be announced in OND and JFM of FY25-26.
- Only Partners who register and qualify in any two of the three Premier Leagues FY 2025-2026 will be considered eligible for the League of Champions FY 2025-2026.
- The scheme registration is mandatory to avail the benefits, and the registration link will be closed on 20th July'25 for PL 1.
- Registrations must be completed for each subsequent quarter/Premier league. A fresh registration is mandatory for every scheme in each of the three Premier Leagues.
